

**NO PURCHASE NECESSARY. OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, 18 OR OVER, WHO ARE SAM'S CLUB MEMBERS IN GOOD STANDING AS OF NOVEMBER 14, 2018.**

- 1) **Promotion Timing:** The Dove Men + Care Big Game 2019 Sweepstakes (the "**Promotion**") begins 9:00 a.m. Eastern Time ("**ET**") on November 15, 2018 and ends at 11:59 p.m. ET on January 15, 2019 (the "**Promotion Period**").
- 2) **Eligibility:** The Promotion is open only to legal residents, of the 50 United States and the District of Columbia who are 18 years of age or older and Sam's Club members in good standing as of November 14, 2018. Employees of Conopco, Inc., d/b/a Unilever (the "**Sponsor**"), their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, including Don Jagoda Associates, Inc.
